In March this year, Arend Venter was recognized as a Citrus Legend at the CGA Citrus Summit. It was with great sadness that we heard of the passing of Arend this week. Arend touched the lives of many in the citrus industry – and his hard work formed the basis for a successful citrus industry. He will be missed.

USA

Next week all eyes will be on Johannesburg as South Africa hosts the AGOA (African Growth and Opportunity Act) Summit. Being in Washington this week allowed me the opportunity to meet with both the United States Department of Agriculture (USDA) and the United States Trade Representative (USTR).

Since 1998 South Africa has exported citrus to the USA from the Northern and Western Cape, growing from 200 000 cartons (15 kg) to over 60 000 tonnes. AGOA comes up for review in 2025, and as always there is concern about renewal and continued South African inclusion. AGOA is important to existing growers who enjoy duty-free access to the US market. This puts South Africa on an equal footing with southern American competitors who also have preferential trade agreements. AGOA is not a trade agreement, which means that it needs to be renewed once the term ends (in this case ten years from 2015 to 2025). It is hoped that the renewal will be secured soon so as to ensure confidence in exports going forward. In the longer term, the citrus industry would prefer a trade agreement to be concluded as that would be more secure and could include many aspects other than just tariffs.

For the rest of the country – representing 85% of the industry – US access is awaiting the conclusion of the final rule for importation of citrus fruit from areas with CBS – a final rule that was concluded in 2016 but has yet to be signed (a process that normally takes six months). There is hope that this issue will also be discussed during the AGOA Summit deliberations. The wider access to the USA is particularly important for the mandarin sector, as plantings in Limpopo and Eastern Cape are now bearing export quality fruit. Importers of mandarins in the USA have indicated a preference for summer citrus from South Africa, which does not impact domestic US supplies and ensures consumers remain loyal to the mandarin category throughout the year.

CITRUS COORDINATING MEETING

For many years DALRRD have held a citrus coordinating meeting which allowed a post-mortem of the previous season, and planning for the following season. In a letter from DALRRD's DDG Serage, CGA has been informed that there will be no coordinating meeting in 2023. In that letter, the DDG states that "we will be arranging meetings directly with growers to provide post-season feedback".
